most iconic tourist asset. Huge economic impact. 8-12 million people visiting the falls, large
% go on this boat. This is the "hub" of a hub and spoke strategy

- Waters Street assets MEDIUM to HIGH?
 - South Docks (Youngstown) close to jet park ride. Have community clubs, youth clubs etc that use this
 - o North Docks (Youngstown) more secluded, also includes salmon rearing

- o <u>McDonough Marine</u> check for restaurant, gas dock.
- Hedley Boat Company separate marina charter boats, recreational boating, boat repair (staging area for Olcott harbor breakwater REDI project)

- <u>Pump</u> Between Hedley and McDonough Marine there is a pump that has been undercut by erosion (REDI project)
- Newfane Shops Boardwalk shops and boutique
- Olcott Beach Carousel Park Hershell carousel in there, right across street, respite area for tourists when visit beach or fishing
- Area Farms:

 - Mayer Brothers (ciders & juices)
 - Russels U-Pick blueberries
 - Blackwood ciderworks
- Niagara County orchards and vineyards SC member can follow up with a list
- Carlton Assets Clustered along Oak Orchard Creek. do have erosion on banks
- Hydropower from the NYPA Power Project in Lewiston economic driver for the region with low-cost power to companies in a 30-mile radius of the plant tied to thousands of jobs.
 Vulnerability to water level fluctuations may be lower since the <u>Power Authority reservoir</u> is completely human controlled as far as water intake
- <u>Somerset</u> 180 aces between Somerset bottling and Baehres between Mayer brothers and power plant (being decommissioned
